## BRINGING RADIATION TREATMENT TO MOSES LAKE

### Your Local Cancer Care Campaign Reaches \$3.5 Million Goal

The *Your Local Cancer Care* capital campaign has reached its goal of raising \$3.5 million to bring a radiation treatment facility to Moses Lake, the Columbia Basin Cancer Foundation and the Confluence Health Foundation announced this month.

“The region’s support shows just how important this project is to everyone involved,” said Abel Noah, Confluence Health Foundation vice president and executive trustee. “This effort is about the care and comfort of our patients, which is the top priority for all of us. We are excited to bring radiation care to Moses Lake. Thank you everyone for helping us reach our goal.”



The radiation facility includes a linear accelerator that can administer the latest cancer treatment protocols and decrease the hours spent by cancer patients traveling outside the Columbia Basin to receive care. The remaining \$3.5 million of the \$7 million project will be funded by Confluence Health.

“Being able to provide treatment locally is now more important than ever,” said Dr. Evan Michael Graham, Confluence Health doctor of internal medicine and president of Columbia Basin Cancer Foundation. “My heartfelt thanks goes to everyone who supported us – together we’ve made Moses Lake and the Columbia Basin an even better place to call home.”

The Columbia Basin community pushed the effort to its final goal by raising \$250,000 during July in answer to an anonymous \$250,000 challenge grant issued to the *Your Local Cancer Care* capital campaign.

“We’re thankful for the Columbia Basin community coming together and helping us finish the challenge grant,” said Columbia Basin Cancer Foundation Executive Director Angel Ledesma. “We couldn’t have done it without the support of this generous region.”
